The Test/Trial Secretary and Chairperson have no obligation or responsibility for providing service through a public address system for the purpose of calling or locating dogs that are not brought to the testing area when required.

## WAIT LIST INFORMATION

**A Wait List** will be created to fill withdrawn entries after the trial's closing **February 09, 2024**. A maximum of **10 entries per test** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to **Friday February 9, 2024**. No entries may be withdrawn with a refund after closing on **Friday February 9, 2024**. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

**Entry fees shall not be refunded** in these tests for absent, disqualified, excused by veterinarian, judge or barred from the competition by the Show Committee. Any dog aggressive to persons or dogs will be removed. If, because of riots, civil disturbance, or other acts beyond control of the hosts, it is impossible to open or complete the show, no refund of entry will be made.

## SIGN-IN and CRATING Areas

There will be a secretary table for check-ins and information.

Dogs will be crated out of view of the Fetch test area. Please work out of your vehicles or bring a crate to put under the provided tenting area. Loud or disrupted dogs cannot be crated in the tenting area and must be quiet in the parking area.

Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. ## NOTICE TO EXHIBITORS

### **Dogs Eligible to Enter the AKC FETCH Test**

- The test is open to all dogs at least 6 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL number, or dogs enrolled in the AKC Canine Partners Program.
- Females in season may enter. They will run at the end of the day. Should wear panties to prevent soiling the test area.
- Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, and the dog doesn't appear to be under undue stress in the opinion of the judge.

**Collars, Leashes and Harnesses** Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They may not wear prong collars, e-collars, head collars, muzzles or body harnesses. Leashes need to be 4 to 6 feet in length. **No flexi leads allowed on the property.** Dog must be on leash at all times except when being tested.

**Grounds will be available from 9:00 am to Completion of the test**

**Please keep the trial site clean.** We ask your cooperation so the we may continue using the facility for future tests. Please pick up after your dog.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

## DIRECTIONS TO THE TRIAL SITE

**DIRECTIONS:** From I-4 Exit 25 County Line Road. Turn right. Follow County Line Road (approximately 8 miles) to Ewell Road. Turn left on Ewell at the traffic light. Follow Ewell Road (approximately 4 miles) to Irby Lane W (on the left. Turn left – property on the left. Pass the house to the white mailbox. Turn in after the mailbox to park.

## FETCH GUIDELINES/RULES

- **AKC Fetch is a pass-fail noncompetitive test.**
- **No food rewards are allowed in the test area.**
- **Handlers may not use “imaginary food” attempting to guide the dog.**
- **Clickers and toys may not be used as reinforcers or lures.**
- **Please crate or keep dogs in the spectator area so they do not bother the dogs being tested.**
- **NOVICE Level:** Tennis balls (or equivalent), bumpers (no scent/food), or toys (able to be thrown 30 ft.) may be used.
- **INTERMEDIATE Level:** Tennis balls (or equivalent), bumpers (no scent/food), or toys (able to be thrown 50 ft.) may be used
- **No dumbbells or gloves are allowed in Fetch tests.**
